Eric Belsky

Eric Belsky, managing director of the Joint Center and a lecturer in Urban Planning and Design published the working papers "[The Dream Lives On: The Future of Homeownership in America](#)" and "[The State of Mexico's Housing: Recent Progress and Continued](#)

Challenges". He contributed chapters to two books, "Crossing Over to an Improved Era of Community Development" (in the book *Investing in What Works for America's Communities*) and "Planning for Inclusive and Sustainable Urban Development" (in the book *State of the World 2012*). He also served as an advisor to the Bipartisan Policy Center's Housing Commission, and travelled around the country giving presentations and taking part in roundtable discussions at FHA, Fannie Mae, and other housing industry organizations.

Neil Brenner

Neil Brenner's most recent publication is "Theses on urbanization," which appeared in *Public Culture*, 25, 1, 2013, which has also been translated into Spanish in the January 2013 issue of the Argentinian journal *Nueva Sociedad*. His pamphlet *The Afterlives of Neoliberalism* (co-authored with Jamie Peck and Nik Theodore) was published in the Civic City Cahiers (CCC) series in late 2012 by the Architectural Association's Bedford Press. Brenner recently gave a lecture, "The urban age in question," at the Graham Foundation's Chicago Expander/Archeworks events series.

Diane Davis

Professor Diane Davis continues her research on Latin American cities as well as on urban planning theory and practice. This spring she has articles on urban megaprojects forthcoming in the Journal of Urban Affairs and in a book titled **Urban Megaprojects: A World Wide View** (edited by Gerardo del Cerro, Emerald Press); a chapter on rescaling state security practices in response to urban violence in Mexico City (co-authored with GSD student Guillermo Ruiz) forthcoming in **Policing Cities: Securitization and Regulation in the 21st Century** (edited by Randy K. Lippert and Kevin Walby, Routledge); an article on the built environmental foundations of insurgent urbanism in cities around the globe forthcoming in Thresholds; and a chapter on the role of imagination as a method for generating knowledge of possible urban futures (with Tali Hatuka) forthcoming in **Research Methods in Planning** (edited by Elisabete A. Silva, Patsy Healey, and Neil Harris, Royal Town Planning Institute).
